Please read these Terms of Use ("Terms") carefully before using DayTriply ("the App"). By downloading, installing, or using the App, you agree to be bound by these Terms and our Privacy Policy. If you do not agree, do not use the App.

DayTriply is operated by an individual developer based in the Netherlands.

1. Eligibility

You must be at least 13 years of age to use DayTriply. By using the App, you confirm that you meet this requirement. If you are under 18, you confirm that you have obtained parental or guardian consent.

2. License to Use the App

We grant you a limited, non-exclusive, non-transferable, revocable license to use DayTriply for your personal, non-commercial purposes. This license does not include any right to resell, sublicense, or commercially exploit the App or its content.

3. User Accounts

3.1 Account Creation

You may sign in using Google Sign-In or Sign in with Apple. You are responsible for all activity that occurs under your account.

3.2 Account Termination

We reserve the right to suspend or terminate your account if you violate these Terms, without prior notice or liability.

4. Subscriptions and In-App Purchases

4.1 Paid Features

DayTriply offers subscriptions and/or one-time in-app purchases that unlock additional features. All transactions are processed by Apple through the App Store.

4.2 Billing and Renewal

Subscriptions automatically renew unless cancelled at least 24 hours before the end of the current billing period. Your Apple ID account will be charged upon purchase confirmation and at the start of each renewal period.

4.3 Managing Subscriptions

You can manage or cancel your subscription at any time through your Apple ID account settings. Cancellation takes effect at the end of the current billing period; you will retain access to paid

features until then.

4.4 Refunds

All purchases are subject to Apple's refund policy. We do not process refunds directly. To request a refund, visit <https://reportaproblem.apple.com>

4.5 Price Changes

We reserve the right to change subscription prices. We will provide advance notice of any price changes. Continued use after a price change constitutes your acceptance of the new price.

5. Prohibited Conduct

You agree not to:

- Use the App for any unlawful purpose or in violation of these Terms
- Attempt to reverse-engineer, decompile, or create derivative works of the App
- Use automated tools to scrape, crawl, or extract content from the App
- Interfere with or disrupt the performance or security of the App
- Impersonate any person or entity, or misrepresent your identity
- Upload or transmit any content that is unlawful, harmful, or infringes third-party rights

6. Intellectual Property

All content in DayTriply — including text, graphics, logos, travel content, and software — is the property of DayTriply or its licensors and is protected by applicable intellectual property laws. You may not copy, reproduce, or distribute any content without our prior written permission.

7. User-Generated Content

If you submit feedback or other content within the App, you grant us a non-exclusive, worldwide, royalty-free license to use and incorporate such content to improve the App. You represent that you have the right to submit such content and that it does not violate any third-party rights.

8. Third-Party Services

DayTriply integrates with third-party services including Google (for authentication and AI features) and Apple (for authentication and payments). Your use of those services is subject to their respective terms and policies. We are not responsible for the practices of third-party services.

9. Location Services

The App may request access to your device location to provide contextual features. You can revoke location access at any time through your device settings. Denial of location access may limit certain features.

10. Disclaimer of Warranties

DayTriply is provided "as is" and "as available" without warranties of any kind, express or implied, including but not limited to accuracy of travel content, uninterrupted availability, or fitness for a

particular purpose.

11. Limitation of Liability

To the fullest extent permitted by applicable law (including Dutch and EU consumer law), we shall not be liable for any indirect, incidental, or consequential damages arising from your use of DayTriply. Our total liability for any claim shall not exceed the amount you paid to us in the 12 months preceding the claim.

12. Consumer Rights (EU / Netherlands)

Nothing in these Terms limits your rights as a consumer under Dutch law or EU regulations, including the right to a conforming digital service and applicable statutory guarantees.

13. Governing Law and Disputes

These Terms are governed by the laws of the Netherlands. Any disputes shall be subject to the exclusive jurisdiction of the courts of the Netherlands. For EU consumers, mandatory consumer protection provisions of your country of residence also apply.
